2. Admit Card for the Examination will be issued to eligible candidates from 10.01.2018 to 12.01.2018 (10.00 hrs to 14.00 hrs) by the CBLR section, Custom House, Tuticorin. Admit Card will be handed over to the candidates only and Admit Cards are not being sent directly to the candidates through post or courier. In exceptional case, if any candidate is unable to collect the Admit Card personally, he may authorize any person in writing, who is having a valid Customs Identity Card, to collect Admit Card, on behalf of him/her. All candidates are advised to collect their Admit Card within the prescribed period.

3. All Admit Cards will be duly signed by the Assistant Commissioner (CBLR) and stamped with Customs Seal. Hence, candidates may ensure the same while receiving Admit Card and candidates possessing invalid Admit Card will not be allowed to appear for the examination.

Venue:- Conference Hall, 1st Floor, Custom House, Tuticorin

4. Candidates are requested to report at the examination hall positively by 09.45 AM i.e. fifteen minutes before the commencement of the Examination. Candidates will not be allowed to carry Mobile Phones / Electronic Gadgets / Books, etc. inside the examination hall. Hence, they are instructed not to possess these items with them while entering the examination hall.

5. Candidates reporting later than 10.30 AM will not be allowed to write the examination and be treated as ABSENT.
