# FRESH POINTS RAISED FOR CONSIDERATION:

During the pandemic situation and Lockdown the E-office may be functioned effectively on receipt E-mail with required attachments from the trade to the

respective department/ officers. The process of E-Office shall be faster and quick  $f_{0t}$ earliest response to the Trade.

E-office has already been made functional in this office. Necessary Reply: instructions has been issued to the officers to consider those correspondence received through our official email wherein any immediate action is warranted.

## (b) Import BE clearance against copy documents:

As there is a delay in receipt of Original documents due to the erratic functioning of courier, we are unable to submit the original documents in time for clearance. Hence, We request you to kindly grant OOC for FAG assessed or RMS facilitated Bills of Entries based on the required documents uploaded through E-sanchit for clearance of imported goods and also if there is any Free Trade Agreement/duty benefit under CAROTAR involved, the Certificate verification/defacing and OOC may be granted against copy of Certificates with an undertaking from the importer for the production of Original certificate.

Vide per Board's Circular No.32/2020-Customs dated 06.07.2020 & Reply: 45/2020-Customs dated 21.08.2020, for uniformity, Board has instructed all field formations to adhere to directions, which requires the submission of original hard copy of a COO for defacement.

In this regard, if any difficulty is faced by the Trade, the cargo may be cleared against copy documents of Certificate of Origin (COO) by preferring the provisional assessment of Bill of Entry, which would be subject to the conditions that importer furnishes a security amount equal to the difference between the duty provisionally assessed under section 18 of the Customs Act, 1962 and the preferential duty claimed. Further, on receipt of Original COO from the exporting country, the same may be produced to this office for defacement and so as to assess the BE finally.

Action: AC (TSK)

#### c) Waiver of Late filing Fine:

During this pandemic all over the world, there are lockdown restrictions at the Port of Loading and in the place of issue of the BL and thereby the required documents for filing the BE as per the latest amended provisions of the Section 46 of the Customs Act, 1962 could not be fulfilled by the Importers. During the similar situations in the last year, the waiver of fine for late filing of BE was provided on a Pan India basis by the CBIC. Now, the situation is being dealt separately at each Customs Location and considering the lockdown scenario, the waiver of penalty for late filing shall be considered favourably at our customs station.

**Reply:** Presently, no such instructions have been received from the Board. Though the Chennai VII Commissionerate has reportedly issued Facility Circular for waiver of late fee, the same might have been issued considering the severity of Covid-19 spread in and around Chennai. Such Circular for Waiver of late fee will be issued by Tuticorin CH either based on Board's instruction or on need basis considering the Covid-19 situation in Tuticorin District.

Action: AC (Policy).

# d) Gate out/in process of Export Laden containers

We request to implement the Gate out of Export laden containers from CFS and Gate in at Port as per the procedure laid down in the board circular 30/2020 dtd.22nd June 2020 and subsequent Tuticorin Customs Public Notice 17/2020 dtd 2nd July

2020 as we are facing the difficulty to commute our staffs from CFS to Gate and also to facilitate ease of doing business.

#### 2) Deletion of Other CVD.

After the budget modification the BEs filed under the Chapter Heading 2710 attracts additional duty towards Transformer Oil vide notification number 190/78 has to be deleted by re-calling and re-assess the bill of entry which leads to delay in clearance especially for bulk Liquid cargo of Naphtha or Fuel Oil in Tanker Vessels are facing much of the difficulties arriving on weekend or holidays. We have also represented through various forums to CBIC and DG systems. Till we get a modification in system, we request you to kindly issue a standing order for re-calling and re-assessment of BEs without any intervention on routine basis. We also attached herewith standing order issued by Commissioner of Customs, Chennai vide order No. Order No. 10/2021 dated 17.05.2021 on the similar issue for your kind reference.

**Reply:** A reference has already been made from EDI Section of Custom House, Tuticorin to the DG Systems to rectify the above issue and a Public Notice to lessen the difficulty faced in recalling of BE for re-assessment has been issued shortly in line with Chennai Customs Commissionerate.

#### 3) IGST/Drawback Scroll issues - Reg

When the scroll is generated for bunch of shipping bills, in which if one exporter IFSC is mismatched, the entire scroll of all shipping bills will be bounced back to the department and the exporters are not getting their refund in time. This resulted in payment of IGST/ Drawback is pending for past two months.

#### [Tuticorin Customs Brokers Association]

This office has no role in rectification of the above issue as the same has to be resolved by the O/o the PFMS, New Delhi through the Office of the DG Systems and Data Management, New Delhi. In this regard, a letter was already addressed on 08.04.2021 by the Commissioner of Customs, Custom House, Tuticorin to the DG Systems and Data Management, New Delhi to take up the matter with the Office of the PFMS, New Delhi. Further, it is informed that this issue was already raised by the TCBA, on 08.04.2021 for which the reply was furnished to them on the same day itself. The officials of the TCBA were requested to sensitize all exporters to update their Bank Particulars i.e. New IFSC Code in the EDI System immediately so as to prevent further recurrence of the same issue in future.

In this regard, a Public Notice No. 08/2021 dated 21.04.2021 was also issued by the Commissioner of Customs, Tuticorin informing the exporters to update their correct bank particulars specifically the IFSC code with the EDI system consequent upon the merger of Nationalized Scheduled Banks, urgently. The status of the different banks consequent upon merger was also mentioned for ease of reference. Hence, action in this regard has to be initiated by the TCBA by way of sensitizing the exporters to update their correct bank particulars with the Customs EDI system.

Action: AC (Drawback & IGST)

# 4) Functioning of CFS on holidays:

We have been informed that over time facility is not permitted for CFS on holidays. We request you to kindly permit export clearance on holidays other than national holidays (26th January, 15th August & 2nd October) on overtime basis. This will facilitate export cargo to connect the planned mother vessels from Colombo.

[Tuticorin Customs Brokers Association] Reply: On need basis, the required permissions for import/export clearance on payment of applicable MOT fees are being considered depending upon the urgency and volume.

Action: AC (CFS & ICD)

## 5) G Card Exam:

G - Card examination have not been conducted for more than 3 years and it is requested to conduct the same at the earliest and on yearly basis.

#### [Tuticorin Customs Brokers Association]

Reply: Due to ongoing Covid-19 Pandemic and lockdown situation, no venues are available where G Card examination could be conducted. Once the spread of Covid-19 is contained in this District, the proposal to conduct the G-Card Exam will be taken up for consideration. In future, if situation allows, the same will be conducted on yearly basis.

Action: AC (CBS)

#### 5) Single Window Clearance system- PGA - Import shipments

The SWIFT program initiated during 2016 and it was successfully having a link with FSSAI & PQ and seamless process of documents were happening. However, recently there is a system linking issues with PGAs, we have to approach the concerned group Assistant Commissioner to get intervention for clearance of cargo.

#### [Tuticorin Customs Brokers Association]

Reply: The above issue is only a temporary system related technical glitch. Only very few documents are not automatically linked with other PGAs. In such cases, the AC (Imports) is linking such documents manually so as to ensure smooth clearance. However, if the problem persists, the same will be taken up to the DG Systems, in case of necessity.

Action: AC (Import Assessment)

#### Clarity sought on overtime for CFS/ICD after office hours and on holidays 6. other than closed holidays.

#### [NACFS, Tuticorin]

In this regard, the instructions to work on 24x7 basis have been issued to Reply: ensure that all goods including raw material required for Covid-19 medical supplies, other supplies, consumable etc. are reaching the concerned on emergency basis and to ensure that the seamless flow of economic activity is not disturbed during the lock down period. Such instructions will not affect the provisions of Section 36 of the Customs Act, 1962 relating to MOT fees. Therefore, MOT has to be paid either by the CHA or CCSP (CFS/ICD). In case the same has not been paid previously, the same shall be paid forthwith fully along with arrears.

Action: AC (CFS & ICD)
