PUBLIC NOTICE NO. 18/2021

Subject: Issuance of Port Clearance (PC) for vessels sailing from the V. O. Chidambaranar Port - reg.

Attention of all Exporters/Importers, Port Terminal operators, Shipping lines, Shipping Agents, Transhippers, Custodians, Freight forwarders Customs Brokers, Member of Trade and other Stakeholders is invited to the request made by the trade for grant of Port Clearance (PC) in online mode for vessels sailing from the V. O. Chidambaranar Port. The issue was examined in details as there are 20 different documents/declarations to be filed and payment of lighthouse dues, marine dues etc. is to be ensured before grant of Port Clearance.

- 2. Considering the aim for expeditious issue of Port Clearance by Customs while ensuring compliance of all legal requirements of filing declarations, production of documents by concerned persons, the following procedure is prescribed with regard to issue of Port Clearance (PC) for the vessels sailing from the V. O. Chidambaranar Port.
- 3. The 'Steamer Agents may scan all the required/mandatory documents (As per list attached) and mail them to ig.tutcus@gmail.com. Import General (IG) Section would process the documents for issuance of Port Clearance (PC). The port clearance will then be issued by Assistant Commissioner (IG) and the same will be forwarded to the email of the concerned Docks' Superintendent. The said e-mail would also indicate whether the application for port clearance is complete and if not, the specific additional documents that are required to be collected by the Superintendent of Customs at Docks before handing over the hard copy of "Port Clearance" to the Streamer Agent would also be indicated. The said additional documents will be collected by the Superintendent of Customs from the Steamer Agent before handing over the hard copy of "Port Clearance". All these additional documents that are collected from the Steamer Agent may be scanned and forwarded by the Superintendent of Customs, Docks through the above said e-mail to IG Section along with a note indication therein the actual time and date of sailing of the vessel for filing purpose.

4. In case of any difficulty in implementation of the above Public Notice, the old practice of granting Port Clearance physically may be continued in consultation with Superintendent/Assistant Commissioner (Docks).
