The written examination of Customs Brokers Licensing Examination, for the Year 2024, shall be conducted by NACIN in the Month of March-2024 at the designated examination centers across India.

Complete application is to be submitted in person or by Registered/ Speed Post in Form-A (available in the CBLR, 2018) along with two passport size photos and self-attested documents on citizenship (Aadhaar/ Passport/ Voter Card), educational qualification, financial viability, mobile number, e-mail id and other requirements along with the prescribed fee of **Rs.500/-** (Rupees five hundred only) from <u>18.10.2023 to 17.11.2023 up to 06:00 PM</u> to the Principal Commissioner/ Commissioner of Customs/ Customs (Prev)/Central Tax & Customs, having jurisdiction over the area where the applicant intends to carry on his business. Applications sent by post, in case received after the last date shall not be entertained.

The online written examination will be a Computer Based Exam with Multiple Choice Questions (MCQs) of **two and half hours (10:30 hrs to 13:00 hrs) duration**. Questions will be bilingual i.e. in English and Hindi. The pattern of the examination shall be as follows:

The syllabus of examination is prescribed in Regulation 6(7) of the Customs Brokers Licensing Regulations, 2018, as amended. Those qualifying in the said examination will have to appear for oral examination in terms of Regulation 6 of the said Regulations.

The oral examination will be held during the second quarter of the calendar year 2024. The pass percentage marks for qualifying in the oral examination shall be 60%.
