Sub: Customs - Form 'G' Written Examination under Regulation 13 of CBLR, 2018 to be held on 30.07.2022.

In continuation to the Notice dated 14.07.2022, the following instructions are hereby issued to the Candidates for their follow up strictly.

- Candidates are requested to report at the examination hall positively by 08.30 AM 1. i.e. one Hour and thirty minutes before the commencement of the Examination and to cooperate with customs officials for frisking. Before entering the venue the candidates requested to produce their Admit Card and H Card to the Customs Officials for verification. If any discrepancies arise the customs officials may contact examination Control room.
- Candidates will not be allowed to carry Mobile phones (even in switch off mode) / 2. Electronic Gadgets/ Book, pager or any electronic equipment or programmable device or storage media like pen drive , smart watches etc., or camera or blue tooth devices or any other equipment or related accessories either in working or switched off mode capable of being used as a communication device during the examination is strictly prohibited. Hence, they are instructed not to possess these items with them while entering the examination hall. Any infringement of these instructions, the candidates will be barred to write any customs conducting examinations at all India level.
- Candidates are advised in their interest not to bring the banned items as mentioned 3. in the para no. 2 including valuables as the Customs Department will not be responsible for the misplacement of the any such items.

- Candidates reporting later than 10.00 AM will not be allowed to write the 4. examination and be treated as ABSENT.
- No candidate will be allowed to leave the examination hall prior 01.00 PM i.e. before 5. conclusion of the examination.
- Candidates should not write any information indicating their identity like their Name 6. /Roll No/ Name of their company etc., or otherwise their answer sheet will not be validated.
- No Attendees of the candidate is allowed inside the premises of the examination 7. venue.
- Drinking water facility will be available in the Examination Hall. Hence, Candidates 8. are advised not to take any water bottles inside the Examination Hall/ premises.
- The candidates should record their responses with a Blue Point Pen only. No marks 9. will be awarded for overwriting.
