At the outset, the Chairman welcomed the Officers, members from other agencies and trade representatives. During the meeting, the following issues raised by the members were taken up for discussion and solution.

POINTS RAISED FOR CONSIDERATION/ POINTS RAISED BY TUTICORIN CFS ASSOCIATION

Question:- 1. Further to PTFC / CCFC meetings held during June and July, 2023 regarding Maersk Line issue, As per the instruction of the Commissioner to write with specific inputs to the Custom House, we have forwarded a mail ref. no. TCFSA/2023/07/44 dated 31.07.2023 & Our Letter No. TCFSA/2023/09/59 dated 21.09.2023. Highlighting the Maersk line issue since they are not following the guidelines of PN 2/2012 as directed by Tuticorin Custom.

Reply: - Commissioner assured that this office will communicate to Maersk Line Office and address the issue and try to resolve the difficulties faced by trades. Commissioner also advised the meeting member to explore other possible alternatives.

Question: -. Clearance of long pending un-cleared / seized containers lying in CFS due to various issues.

Ref: Our Letter No. TCFSA/2023/06/24 dated 06.06.2023.We await Details from Customs for follow up on clearances of UCC /Seized Cargo.

Reply:- Commissioner informed the trade to prepare two separate lists of containers (1) Those which are pending because of NOC Pending from other agencies like DRI, PCB, PQ or investigation pending from the departmental side 2nd one is the list of the containers which are delayed because of other issues. Commissioner informed that this office is taking necessary actions to dispose as many as possible except some cases where DRI NOC required.

question:- 3. Lan IP awaited from Customs EDI for MPLS Connections.

Reply:- Commissioner informed the trade that HARI CFS is already received LAN IP from DG System on 17.10.2023 and for the Kerry Indev Logistics Pvt. Ltd. case has been sent to DG System and it is pending with them. This office will take up the issue with DG System and informed the trade to check with DG System. This office has forwarded application in time.

(EDI SECTION)

Question: - 4. PQ clearance delay for e-auction cargo.

Customs is issuing letter to the PQ authorities, advising to issue a PQ clearance to the H1 Bidder for clearing cargoes under e-auction at the earliest. But the issuances of PQ clearances are getting delayed, since they are asking more documents (like below mentioned) for which the custodians do not have any access / visibility to submit:

- a. Importer's five-year IEC history.
- b. An importer authorization letter to be provided by Customs for the specific Bill of Lading (BL).

In general: the PQ authority is issuing PQ clearance within 24 hours for the normal clearance under BE home consumption, but they are taking more than a month period to issue the PQ for e-auction cargoes.

Reply: - Commissioner assured that this office will communicate to PQ Authorities and address the issue also try to resolve the difficulties faced by trades.
