Sub: Creation of section based government email IDs in Custom House, Tuticorin – Reg.

In order to secure digital environment, CBIC has informed that:

- All the Customs & GST field formations / Directorates / Officers shall immediately switch over to gov.in / nic.in E-mail IDs for all their official communication; and
- It has been decided to configure the security policy in all AIOs on the CBIC network in such a way to disallow public e-mail IDs like Gmail, Yahoo, Hotmail etc.

It is hereby informed that all the officers working in this office have been individually provided with dedicated government email IDs for this purpose. The section-based email IDs that have been created and mentioned below shall be used by the corresponding/respective officers and it shall be handed over to the successors for the purpose of continuity and knowledge transfer.
