Subject : Export of Beach Sand Minerals – Reg.

Attention of Exporters, Customs Brokers, Custodians of Imported/Export Goods, Steamer Agents, officers of Customs and all others concerned are invited on the above subject.

2. The Assistant Director, Geology and Mining, Tuticorin has informed that the Govt. of Tamilnadu vide its G.O.Ms No. 156/8-08-2013 and G.O Ms No. 173/17-09-2013, has directed to stop the mining operation of all private mining lessees issued for Beach Sand Minerals, pending completion of inspection by special team and to stop the transport permit with respect to the lessees granted to private parties.
3. Also, complaints are being received from various Beach Minerals Associations, Trade Unions and General Public regarding the eligibility for export of Beach Sand Minerals, in light of Ban imposed by the Government of Tamil Nadu vide G.O. G.O.Ms No. 156/8-08-2013 and G.O Ms No. 173/17-09-2013.
4. The District Collector, Tirunelveli, has forwarded minutes of the District Level Committee Meeting vide letter dated 9-11-2016, requesting this office to insist on certain documents issued by state authorities, before allowing the beach sand minerals for export.
5. In view of the above, it has been decided to verify the source of Beach Sand Minerals being sent for export. The necessary certificates/ documents viz., Certificate of legally mined minerals from the concerned District Collector/transport permits along with bulk permits, certifying the legal source of such Beach Sand Minerals brought to the Customs Area for export under Section 50 of the Customs Act,1962 are required to be produced.
6. Accordingly, as an interim measure all the exporters of Beach Sand Minerals are hereby required to produce the aforesaid documentary proof obtained from competent authority.
