PUBLIC NOTICE NO. 04/2018

Sub: Implementing Electronic Sealing of containers by Exporters-Reg.

Attention of the Exporters/Custom Brokers/Vendors/ Shipping Agents and all concerned is invited to the Board Circular No. 51/2017-Cus. dated 21.12.2017 on the above subject.

- 2.1. In terms of Board Circular cited above, e-sealing of containers is mandatory with effect from $1^{\rm st}$ March, 2018 for the entitled exporters who intend to export through this Port (Custom House, Tuticorin -INTUT1). Hence the following category of exporters are directed to strictly comply with the Board Circular cited above by switching over to e-sealing with effect from Ist March onwards.
 - i. All AEOs
 - ii. All exporters who have been availing the facility of erstwhile self sealing.
 - iii. All exporters who have been availing the facility of supervised sealing by Central Excise Officers/Customs Officers
 - iv. All exporters who obtained fresh permission for self sealing from Jurisdictional Commissioner of Customs
- 2.2. Since e-sealing becomes mandatory with effect from 1st March,2018 for this Port, the facility of erstwhile self sealing and supervisory sealing by Central Excise/Customs Officers are dispensed with, from 1st March 2018.
- 2.3. It is further informed that the Readers of the following Vendors have been made available in this gate way Port and hence the entitled exporters shall procure eseals from any of the following vendors of their choice for the purpose of export through Custom House, Tuticorin (INTUT1):
 - 1. M/s Ib Track Solutions Pvt. Ltd., Bengaluru
 - 2. M/s Optimus Telematics Pvt. Ltd., Noida
 - 3. M/s Infotek Software Systems Pvt. Ltd., Pune
 - 4. M/s Sepio Products Pvt. Ltd., Vasai
 - 5. M/s Thar Shipping Lines LLP, Bangalore.
 - 6. M/s Pack Seals Industries, Mumbai
 - 7. M/s. Enopeck Seals Industries, Mumbai

- 3. For all those exporters mentioned in Para 2.1 above, who intend to export through St.John ICD, Tuticorin (INTUT6), e-sealing of containers is mandatory from Ist April,2018 onwards. The following Vendors have provided readers in the St.John ICD and hence the exporters, who operates through St.John ICD (INTUT6) shall contact the following vendors for the purpose of obtaining e-seals:
 - 1. M/s Infotek Software Systems Pvt. Ltd., Pune
 - 2. M/s Ib Track Solutions Pvt. Ltd., Bengaluru.
