SUB: Change of Name of the CFS – M/s Continental Container Freight Station to M/s Kerry Indev Logistics Pvt. Ltd. - Reg.

Attention of the Exporters, Importers, Custom Brokers and all concerned is invited to the Public Notice No. 52/2000, dated 23.10.2000 declaring the premises of M/s Continental Container Freight Station situated at No. 4/104-B, Harbour Bye-Pass Road, Tuticorin – 628 008 as Customs Area under Section 8(b) and approving M/s Continental Container Freight Station as Custodian of Import and Export goods brought in the aforesaid Customs area under Section 45 of the Customs Act' 1962 and subsequent approval by Commissioner for inclusion of 61 Cents of land to the CFS vide C.No. VIII/48/194/1999 – Cus. Pol., dated 21.09.2010.

2. M/s Continental CFS, Tuticorin was later re-named as M/s Indev Logistics Pvt. Ltd., Tuticorin vide the IMC's approval communicated vide Ministry of Commerce & Industry, Infra I Section letter No. 16/19/2010-Infra I, dated 15<sup>th</sup> November 2010. Now, the name of M/s Indev Logistics Pvt. Ltd., is again changed as M/s Kerry Indev Logistics Private Limited. Henceforth, the said CFS shall be known as **M/s Kerry Indev Logistics Private Limited** with immediate effect, in all the documents handled in connection with Customs. Except for the change in name, all other contents of the above Public Notice remain the same. The change of name will not wither/take away the responsibility cast upon the CFS Custodian to clear the litigations, Tax disputes, Show Cause Notices, arrears pendency, if any, in the name of M/s Continental Container Freight Station, Tuticorin and M/s Indev Logistics Pvt. Ltd., CFS, Tuticorin.
