Reference is invited to Public Notice No.1/93 dated 28.04.1993 read with Facility Intimation No.06/2007 dated 11.07.2007 of the Commissioner of Customs, Tuticorin wherein the premises of M/s. SEC Services Pvt. Ltd. Tuticorin was declared as Container Freight Station under clause (b) of Section 8 of the Customs Act, 1962 at Survey No.1604/1, 1615/2 and 1615/2A, Tuticorin Bye Pass Road, Madathur Village, Tuticorin for the purpose of storage, examination and loading/ unloading of export cargo into containers.

2. Now, the custodian has requested to shift the CFS premises from their rented premises to their own spacious premises situated at Plot No.8 of SIPCOT Complex, Tuticorin, Survey No.1397/pt, 1398//pt, 1400/18, 1401/pt & 1402/pt, Milavittan Village, Tuticorin.

3. Accordingly, in the above said Public Notice 01/93 dated 28.04.1993 the Second Para under heading DESCRIPTION OF THE AREA AND LOCATION may be read as follows:
