Sub: Customs- ICES Advisory 04/2018 (IGST Refund) - Option to rectify certain Gateway EGM errors-reg.

Attention of all Exporters /Custom Brokers/Steamer Agents/Shipping Agents/MLO/Line Operators/ Trade and Industry and Public is invited to the Facility Intimation No. 02/2018 dated 18.01.2018 on the step by step guide on IGST refund issued by the Directorate of Systems, CBIC New Delhi .

2. The Directorate of Systems has issued ICES Advisory No. 04/2018 (IGST Refund) dated 19.02.2018 regarding the procedures to rectify certain Gateway EGM errors, which is reproduced as under:


“ Please refer to the step by step guide on IGST refunds issued by the Directorate of Systems. As discussed in the annexure to the guide, an option has now been made available in the role of AC (Exports) of ICDs to rectify Gateway EGM errors M and L resulting SB006 mismatch.

In case of error **M (Gateway port mismatch)**, the officer can fill in the actual gateway port of export, and in case of error **L (LEO date > Sailing date)**, the officer can give the actual sailing date as the LEO date.

For making any of the above modifications, the officer may duly verify the transference copies and the sailing details and satisfy himself of the actual export of goods out of India. Once the details are corrected , the exporter may be advised to amend the EGM at the gateway port for successful integration with the updated details. “

3. All the exporters are hereby requested to take necessary action to rectify the SB006 error immediately, wherever possible, to resolve the issue of pending claims of IGST refund.

4. Difficulty faced in this regard if any, may be brought to the notice of this office.
