2. The list of shipping bills with error codes SB003 and SB005 for Custom House,
Tuticorin and ICD, Tuticorin is attached with this facility intimation (Annexure-A).
Accordingly, the exporters and their agents are requested to check the error codes of
SB003 and SB005 .

3. The concerned exporters are requested to e-mail the prescribed concordance table
(in respect of SB005 error) indicating mapping between GST invoices and
corresponding shipping bill invoices in support of the refund claim to the designated
officer, i.e. Assistant Commissioner of Customs, Drawback, Custom House, Tuticorin to
igsttutcus@gmail.com.


4. The concerned exporters are requested to submit the undertakings from both
GSTNs for rectifying the SB003 errors as informed in the Customs circular No 15/2018
dated 06.06.2018 to this office.

5. The List of IECs whose Bank accounts not validated by the PFMS and the list of
shipping bills as on 29.06.2018 which are processed not scrolled out due to non
validation of the bank account by PFMS are attached herewith (Annexure-B and
Annexure-C).

6. In view of the above, the exporters are hereby advised to provide correct Bank account details Viz., Account number, IFS code , IEC code as per the formats attached herewith to the Assistant Commissioner (Drawback) , the designated officer of this Custom House. In this regard, Exporter's quick response is solicited, so as to enable disbursement of amount under IGST Refund and Drawback/ROSL scheme smoothly.

7. Difficulty faced in this regard, if any, may be brought to the notice of this office.
