Sub: Declaration of Container Freight Station set up by M/s.Sical Distriparks Limited., Tuticorin at TUTICORIN PORT in the name and style as M/s.Sical Distriparks Limited, CFS as Customs Area under Section8(b) Customs Act 1962 for handling both import and export cargo-Procedures to be followed.

In exercise of the powers conferred under Clause (b) of Section 8 of the Customs Act,1962, the premises of CONTAINER FREIGHT STATION set up by M/s. Sical Distriparks Limited., Tuticorin at 1297 / 1-2, 3A-3B Harbour Express Road, Opp. to SIPCOT Corporate Office, Madathur, Meelavittan Village, Tuticorin – 628008 with the approval of Ministry of Commerce vide their order No.16/28/2008-Infra-I dated 27.04.2009, 18.03.2010 &15.11.2010 in the name and style as M/s. Sical Distriparks Limited, CFS and its boundaries specified below has been declared as CUSTOMS AREA by Commissioner of Customs, Tuticorin vide Notification No. 2/2011dated 21.4.2011 for the purpose of unloading, de-stuffing & Customs examination of all Full container Load (FCL) containing imported goods and also for the purpose of Customs examination and loading/ stuffing of export cargo in to containers under Customs supervision and sealing of the same by Customs with Customs seal.

DESCRIPTION OF THE AREA AND LOCATION OF PREMISES OF M/S. SICAL DISTRIPARKS LIMITED, CFS

02. Premises having an area of 11.50 Acres of land owned by M/s SICAL LOGISTICS LTD., Tuticorin and acquired on lease agreement by M/s. SICAL DISTRIPARKS LIMITED., situated at 1297 / 1-2, 3A-3B Harbour Express Road, Opp. to SIPCOT Corporate Office, Madathur, Meelavittan Village, Tuticorin-628008, with boundaries on four sides as noted below.

North: Vacant Land (Plot of M/s. Kovil pichai ammal., survey No.1298)

South: Vacant Land (plot of M/s. Thirumani Nadar., survey No.1308)

East: Vacant Land (plot of M/s. Chinni ammal., survey No.1296)

West: Land (plot of M/s. R.Chelliah Nadar., survey No.1297/3c)

03. M/s. Sical Distriparks Limited, CFS has been appointed as Custodian of the goods brought in the aforesaid CUSTOMS AREA for the purposes of Exports and Imports under section 45 of the Customs Act, 1962 and Handling of Cargo in Customs Areas Regulations, 2009.

**04. PROCEDURES TO BE FOLLOWED**

The procedures for dealing with import FCL cargo and export cargo as laid down in Public Notice No.26 / 2004 dt.13.05.2004 issued by this Custom House and CBEC Circular No.79 / 2001 dt.07.12.2001 and Circular No.13 / 2009 – Cus dated 23.03.2009 modified from time to time shall be followed. The procedures outlined in CBEC Circular No.55 / 2000 dt.22 / 2001 dt.17.04.2001 for consolidation of cargo at CFS should be adhered to. Movement of Import laden containers has to be done in accordance with facility intimation No.13 / 2006 dt.23.08.2006 of Tuticorin Customs Commissionerate as amended from time to time.

05. This facility will come into effect from 01.5.2011.


