2. All the Exporters, Customs brokers and the Trade are requested to take note for suitable compliance so that pending Drawback Claims could be disposed off at the earliest.

3. It is hereby informed that Shipping bills pending in Exporter's queue for more than a year for want of reply to queries will be processed in the following manner:
- a) The shipping bills with a query on drawback serial No. will be finalized with the appropriate serial No. applicable, without waiting for a reply from the Exporter.
  - b) The shipping bills with a query on freight and insurance will be finalized after taking freight as 20% of FOB value and Insurance as 1.125% of FOB value, without waiting for a reply from the Exporter.
  - c) The shipping bills with a query on value of hanger, will be processed, reckoning value for kids hanger @RS.3/- per piece and for others @Rs.5/- per piece, without waiting for a reply from the Exporter.

The members of the Trade may avail the benefit of the drive , and difficulties if any , in this regard may be brought to notice of the Nodal officer.
